### **Terms and Conditions**

1. The cost of organisational membership with Forum for Counsellors and Psychotherapists ('Forum') is £90 per annum.
2. The member organisation will subsequently be permitted to book up to a total of 15\* current employees or volunteers on Forum training days at the 'members rate' during the membership year.

*\* where an event has an attendance capacity of less than 30, there will be a limit of 3 places per organisation.*

3. The member organisation will be responsible for making a single payment to Forum on behalf of the attendees listed on the event booking form.
4. In the unlikely occurrence of changes being made to the venue or content of a training day **more than a week prior to the training event**, the individual(s) who has/have signed this agreement on behalf of the member organisation will be notified of such changes by a representative of Forum. In exceptional circumstances where such changes occur **within a week** of the training event Forum will seek to notify both the organisation and individual attendees of those changes.
5. The Forum committee reserve the right to terminate the contract, **with immediate effect**, if it considers the member organisation is not adhering to these Terms & Conditions.
